#### 9.1 REGIONAL FUNDING PROGRAM

#### **PURPOSE OF REPORT**

The purpose of this report is to advise Council of the recently announced Regional Funding Program (RFP) and a requirement to notify the Department of Environment and Conservation of the local governments that form the regional group.

#### **KEY ISSUES AND RECOMMENDATION(S)**

- The Minister for Environment and Water has resolved that regional funding is the preferred method of supporting the ongoing implementation of local government Strategic Waste Management Plans.
- Funding, amounting to \$6.78M, for the Regional Funding Programme has been approved for 2011/2012-2015/2016 so that groupings of local governments will have time to plan and implement strategic projects.
- Phase 1 funding will be based on the number of local governments in the group, regional weightings and population as well as an allocation to update Strategic Waste Management Plans.
- Phase 2 funding will be based on a competitive bidding process with funds allocated based on value for money, alignment of projects with the Draft Waste Strategy and the principles and objectives of the programme.
- Regional Funding Programme funds will only be available to groupings of two or more local governments and, now that the City of Stirling is delivering its waste to Red Hill, it is proposed to invite the City of Stirling to "group" with the EMRC for the purposes of the Regional Funding Programme.
- Details of the local governments that are part of the group must be submitted to the Department of Environmental and Conservation by 6 January 2012.

#### **BACKGROUND**

In 2006 – 2008 the Waste Authority / Department of Environment and Conservation (DEC) introduced a Zero Waste Plan Development Scheme (ZWPDS) and allocated funds for local governments to develop Strategic Waste Management Plans (SWMP). Local governments that formed regional groupings received twice the funding of that given to local governments acting alone.

In 2009 the Minister for Environment approved a Regional Funding Program pilot scheme to assist in the implementation of priority actions contained in the regional SWMPs but there has been no additional funding since then.

#### **REPORT**

Since the completion of the RFP pilot scheme little further progress has been made on implementing the SWMPs, by any of the regional groups, as the follow up funding, that had been promised, was not forthcoming.

The Waste Authority recently sent a letter to all local government CEO's advising them the Minister of Environment and Water has allocated \$6.78M for a RFP. There is a requirement that in order to receive funds local governments are to be part of a regional group. In the case of the member Councils the logical regional grouping is the Eastern Metropolitan Region and that the entity to manage the RFP be the EMRC as it was the entity that managed the SWMP process.

Since the City of Stirling has initiated action to withdraw from the Mindarie Regional Council and, as from 25 July 2011 has been sending all of its waste to be landfilled to Red Hill, there have been some discussions at officer level, regarding the City of Stirling linking with the EMRC member Councils so as to be eligible for funding from the RFP.

As the first round of funding will be allocated on the basis of the number of local governments in the group, regional weightings, population and an allocation for updating the SWMPs there is merit in having the City of Stirling as part of the grouping. Initial advice is that the six member Council's funding will be in the order of \$200,000 based on \$14,000 per local government and \$0.37/head of population and \$5,000 for the rewriting of the SWMP. If the City of Stirling were to be part of the group the funding amount would be in the order of \$274,000 since there would be an additional local government in the regional grouping and the population of Stirling is in the order of 200,000.

Linking the City of Stirling to the EMRC grouping will generate \$74,000 in additional funding and this could be utilised, in conjunction with the City of Stirling, on a project that benefited it and the EMRC. The preliminary discussions, based on the City being invited to be part of the Eastern Metropolitan regional grouping, indicate the City of Stirling officers would utilise any funds that were made available to them to divert wood waste from the Balcatta Transfer Station to the EMRC's wood waste resource recovery project in Hazelmere and/or improving the dry cell battery and E waste recycling programmes.

#### STRATEGIC/POLICY IMPLICATIONS

The RFP funds would be utilised to implement programmes identified in the SWMP that satisfied the Key Result Areas.

- 1.1 To provide sustainable waste disposal operations
- 1.2 To improve regional waste management
- 1.3 To provide resource recovery and recycling solutions in partnership with member Councils
- 1.4 To investigate leading edge waste management practices

#### FINANCIAL IMPLICATIONS

The additional funds have not been anticipated and no provision for the additional revenue has been made in the 2011/2012 Budget. Provision has been made in the 2011/2012 Budget to implement some of the SWMP actions and additional actions can be undertaken as a result of the additional funds.

The inclusion of the City of Stirling in the regional grouping would increase the amount of funds allocated to the regional group.

#### SUSTAINABILITY IMPLICATIONS

The additional funding will enable additional actions that improve the sustainability of waste operations to be implemented.

# A REQUEST FOR COMMITMENT TO REGIONAL GROUPINGS - REGIONAL FUNDING PROGRAM 2011/12 - 2015/16

From 2006-2008, the Waste Authority provided over \$2.8M to local governments under the Zero Waste Plan Development Scheme (ZWPDS) to establish base line data and support the development of Strategic Waste Management Plans (SWMPs) throughout the state. In response, twenty four (24) groupings of local governments and eleven (11) individual local governments developed SWMPs.

Subsequently in 2009, the Minister for Environment approved a Waste Authority Regional Funding Program (RFP) pilot. Under the pilot, regional groupings of local governments were allocated funds in excess of \$2.5M to assist in the implementation of priority actions contained in regional SWMPs.

Following the successful completion of the ZWPDS and RFP pilot, the Waste Authority has resolved to continue a RFP as the preferred method for supporting the ongoing implementation of local government SWMPs. The Minister for Environment and Water has now approved funding totaling \$6.78M for a RFP from 2011/12 to 2015/16. It is considered that running the RFP over five years will allow groupings of local governments adequate time to plan and implement strategic projects.

In phase 1 of the RFP, groupings of local governments will receive notional allocations of funding based on the number of local governments in the group, regional weightings, population and an allocation for updating SWMP's. Notional allocations made in phase 1 that are not committed by 27 December 2013 will be directed into Phase 2 of the RFP.

Phase 2 will comprise a competitive funding process where groupings of local governments that have finalised commitment of funding from phase 1 can compete for project funding based on best value for money, alignment with the nature of targets outlined in the draft Waste Strategy and consistency with the principles and objectives of the program. Both phase 1 and phase 2 funding must be fully committed prior to 26 June 2015 or its availability will lapse.

Please note that RFP funding will only be available to groupings of two or more local governments, individual local governments will not be eligible. Funding allocation and payment is also dependent upon all participating local governments within the RCG having completed and submitted the current or most recent annual census of local government waste and recycling services.

In order for the Department of Environment and Conservation (DEC) to finalise group funding allocations in phase 1, you are invited to email Brendan Mohr at <a href="mailto:brendan.mohr@dec.wa.gov.au">brendan.mohr@dec.wa.gov.au</a> with a list of local governments that you intend to work with as part of the Regional Funding Program. This information may be provided by a lead local government on behalf of a proposed grouping, based on relevant supporting information, and is required by close of business, Friday 6 January 2012. Groups notifying after this date will not be eligible for funding in phase 1 of the RFP.

Once your regional grouping has been finalised and allocations calculated, you will be advised of notional funding available to your group.

A number of information sessions regarding the RFP will be conducted in metropolitan and regional areas. Dates and locations will be advised when finalised.

# Regional Funding Program 2011-2016

#### Historical Background

Between 2008 and 2010, the Waste Authority conducted a "pilot" of the Regional Funding Program (RFP Pilot), by providing funding for a limited period to implement regional Strategic Waste Management Plans (SWMPs) developed under the Zero Waste Plan Development Scheme (ZWPDS). The program was highly successful in encouraging local governments to work together and supported a wide range of initiatives including waste infrastructure projects, the acquisition of plant, waste audits and studies.

In 2009 the Waste Authority commissioned GHD Consultants to conduct an independent review of the ZWPDS and the RFP Pilot to assess the value of these programs, outline their successes and weaknesses and make recommendations arising from the findings of the review.

The review found that to be effective, the RFP needs to flexible as to when local governments can apply for and receive funds, allowing the development of projects they genuinely need, rather than hastily created projects in order to access funds. The experience of the pilot program and the findings of the independent review found that funding needed to be substantial and available over a number of years for local governments to be able to use it most effectively.

#### **New Scheme**

An amount of \$6,780,000 has now been allocated to the RFP for five years from 2011/12 – 2015/16, which will allow regional groups adequate time to plan and implement worthwhile strategic projects.

The program has three stages:

- Stage 1 July 2011 June 2013 Fixed funding stream, where regional groups are allocated a fixed amount based on the number of local governments in the group, regional needs and population
- Stage 2 July 2013 June 2015 Competitive bid funding stream, where regional groups will compete for funds for projects which demonstrate best value for money
- Stage 3 July 2015 June 2016 No funds will be allocated in the fifth and final year of the program which will be for implementation, completion and reporting of funded projects

Local governments will again be encouraged to form regional groupings and undertake projects with regionally developed priorities which are consistent with the Waste Authority's objectives. Only groupings of local governments will be issued funding, individual local governments will not be eligible.


